Client tripped and fell at therapist's salon and broke their hip.




# BUSINESS PROPERTY DAMAGE

## COVERAGE DETAILS

WHILE THE POLICY IS AFFORDABLE, the coverage is extensive. To help you better understand your coverage, we have broken down and explained each element of the policy.

#### **GENERAL LIABILITY**

Coverage that protects you from claims of bodily injury and property damage caused by a third party. In the event of an accident, a massage therapist covered by BBI could have all potential medical expenses and legal fees covered.

### **PROFESSIONAL LIABILITY**

Coverage that protects you from claims regarding errors and omissions while performing your work.

## PRODUCTS & COMPLETED OPERATIONS

The maximum amount your policy will pay in a 12-month period for bodily injury and property damage claims that result from the products you use to perform your services. However, it does not cover your products that are sold or distributed.

### Personal & Advertising Injury

The amount that your policy will pay for claims arising out of one or more of the following offenses:

- False arrest, detention or imprisonment Malicious prosecution Wrongful eviction or wrongful entry Oral or written publications that slander or libels a person or organization
- Oral or written publication or material that violates a person's right of privacy
- The use of another's advertising idea in your advertisement

#### INLAND MARINE

Inland marine insurance covers tangible property that is movable or transportable in nature (e.g. supplies, equipment, or inventory) but excludes coverage for structures and items that are part of the structure.

**A**N ADDITIONAL INSURED is a person or organization (e.g., salon owner, property owner, organization affiliate, etc.) that is not included as an insured under your insurance policy.

Now, you may be wondering why a salon owner would require you to add them as an additional insured on your policy. Here is an example:

A client makes an appointment with their massage therapist for a deep tissue massage. After the massage, the client files a claim against the insured for causing nerve damage to their neck. They also file a claim against the salon in hopes to get more money.

Adding the salon as an additional insured on your policy could provide the salon you work for protection against a filed claim similar to the one mentioned above. It protects the salon or spa from claims relating to your negligence.

Because this risk is present, most salons require their massage therapists to list them as an additional insured before they will sign a contract to work with them.

Purchasing a policy with BBI allows you to add one additional insured for \$15 or an unlimited amount of additional insureds for only \$30.



How To FILE A CLAIM

IF YOU HAVE A MASSAGE INSURANCE POLICY with BBI and need to file a claim, the process is simple. You can give our customer service team a call or shoot them an email, and they will walk you through the simple five-step process.
